

## A NEW CENTRALISED DIGITAL ID – Is it part of a Hidden Agenda?

- 1) Who requested a centralised Digital ID, and why? Did it originate within Australia or was it from foreign influences? It's happening in "lockstep" with overseas nations, so that's a strong clue.

Government and big biz tell us it's personally "convenient", for everyone.

But who else would find it convenient for everyone's personal data stored on a single centralised data base? - Could the major beneficiary be, a NWO?

A New World Order (NWO) has been heralded by many prominent world leaders for decades. The WEF (World Economic Forum) in collaboration with the UN (United Nations) and the WHO (World Health Organisation) have a NWO agenda. All 3 have recommend and are now in the process implementing a NWO. They say we must have a centralised Digital ID and a CBDC (Central Bank Digital Currency). The WHO is also amending their rules (see IHR in 8 & 9). Their agenda is clear if you pay attention to their promotional videos and research their websites.

For more than 85% of my life I have lived and worked in areas where cell phones are useless ("no cell service"), and today I still frequent areas with "no cell service" where I continue to have financial and social interests.

- 2) The government claims its new digital ID is "inclusive". It is not. It automatically excludes all people in areas outside a cell service.
- 3) I have never owned a smart phone and do not want to own one. I won't keep all my personal information in one single basket, (electronically or otherwise).

My household has numerous experiences of being forced by floodwaters to live on a small isolated island. For weeks we have been without a phone, sometimes without grid power and not able to drive to town for months to get supplies. However, flooding of the western plains is beneficial to both the economy and environment. It is the life-blood for many millions of acres. The water is slow moving and slow to drain away on this flat terrain so residents can be flooded-in for weeks or months. This continues to happen and thousands of people in rural/remote Australia may have to survive without services others take for granted. The key to survival is preparation, relying on neighbours, not the authorities, (they cannot be trusted for help), and "don't put all your eggs in one basket". Hence, I will not be 100% dependant on the electricity grid or a phone service. You never know how long your next "outage" will last, especially if the advice for Agenda 2030 from the WEF & UN is believed.

4) History has proven any data can be hacked regardless of who or how it is stored or protected. Pieces of my personal data are ALREADY scattered across various organisations (including governments). Currently, hackers have to crack into at least 2 or 3 data banks to COMPLETELY steal someone's identity. Why would I want a single data bank to have sole control of all my data including ALL MY PERSONAL DETAILS. This new digital ID is to be CENTRALISED, so it will become the ONE STOP SHOP for HACKERS to target.

5) The government claims of "*An accessible, user-friendly, highly trusted, and secure ID solution*". Nobody with a functioning brain can honestly say our governments are now "*highly trusted*", not with their track-record with the truth over the past few years since early 2020. The falling vaccination rates clearly demonstrate more and more people are waking-up to the fact mantras such as "Safe and Effective" were lying propaganda.

6) Will this new centralised Digital ID be equally accessible for every Australian who is within cell phone coverage and owns a smart phone?

Will the Australian government guarantee to include with the proposed legislation that, people will never be incentivised or coerced to apply for its new digital ID? In addition, those who choose not to use or register for this proposed new centralised Digital ID must, be protected by federal, state and local legislation, so they are never subjected to vilified penalisation, or be excluded from employment or society (as was the case and still is for some people, during the covid mandates).

7) Australia must never use a digital ID and/or a CBDC (Central Bank Digital Currency) to implement a SCS (Social Credit Score) as promoted by the WEF, UN and its supporting organisations such as the WHO, (all three organisations are unelected and unaccountable). Chief WEF elites and their supporters are saying we must use the opportunity presented by covid to introduce further initiatives, (ie. impose further lockdowns and controls).

8) Australia must never allow any of our sovereignty to be relinquished to any foreign power, including the UN or the WHO. Both organisations, are now quietly changing their charters (from sources of advice, to dictatorial control). At the moment, the WHO is secretly amending the IHR (International Health Regulations). Some of these amendments are being concealed.

If our Government Leader registers a formal objection before December 2023 the implementation of the WHO's new dictatorial IHR rules might be delayed. However, without a formal objection the WHO's amended IHR will by default start to be implemented worldwide, after the WHO meeting in May 2024. The WHO does not need to seek approval from Australia or any other government, (signatures or approval are not needed from Party States). It's time to exit the WHO.

9) Members of the UN & the WHO are not elected. Members of the WEF are also not elected. The WEF is collaborating with the WHO & UN to impose the agenda of a New World Order to take control over all the nations of the world with the stroke of a digital pen.
