System Administrator
Australian Government Digital ID System (AGDIS)

The System Administrator is responsible for protecting the integrity and performance of the Australian Government Digital ID System (AGDIS). This includes operational support for the AGDIS Administrator Portal (the Administrator Portal).

All System Administrator staff will observe a complete shut down during a prescribed Reduced Activity Period (RAP) from 24 December 2024 to 1 January 2025 (inclusive).

This document specifies business continuity arrangements for the System Administrator during RAP, including preparation activities and appropriate escalation points.

Preparation

Communication with stakeholders

The System Administrator will notify all AGDIS entities of arrangements over the RAP and request they review and update their contacts as required.
